In full consideration for receipt of the requested Media Credential for all related events and activities at the TRACK, I hereby warrant and agree that:

1. I am familiar with and accept there is a risk of serious injury and death in participation, whether as a competitor, student, official or worker, in all forms of motor sport and in particular in being allowed to enter, for any reason, any restricted area; and
2. I have satisfied myself and believe that I am physically, emotionally and mentally able to participate in the TRACK and that my protective clothing, gear and equipment is fit and appropriate for my role as a participant at the TRACK, and
3. I understand that all applicable rules for participation must be followed, regardless of my role, and that at all times during the TRACK, the sole responsibility for my personal safety remains with me, and
4. I will immediately remove myself from participation, and notify the nearest official, if at any time I sense or observe any unusual hazard or unsafe condition or I feel that I have experienced any deterioration in my physical, emotional or mental fitness, or that of protective clothing, gear or equipment, for continued participation in the TRACK.

I UNDERSTAND AND AGREE, ON BEHALF OF MYSELF, MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN THAT MY EXECUTION OF THIS DOCUMENT CONSTITUTES:

1. AN UNQUALIFIED ASSUMPTION BY ME OF ALL RISKS associated with my participation in the TRACK even if arising from negligence or gross negligence, including any compounding or aggravation of injuries caused by negligence rescue operation or procedures, of the Releases, as the term is defined below and any persons associated therewith or otherwise participating in the TRACK in any capacity, and
2.
